Sir,

Whereas the undersigned has been appointed as Returning officer by Met Veterans Association vide letter No. MVA/Election/2026/01 dated 04.06.2026 to hold the election of the Executive Committee of Met Veterans Association (Reg No. HR/018/02596/2023).

Accordingly, the undersigned issued Notification for Election on 08.06.2026 to all the members, to hold the election in the General Body meeting on 11.07.2026. Nomination forms were issued on 19.06.2026. Nomination Forms, duly completed, were received on 25.06.2026, filled by One candidate for One post of President, One candidate for One post of Vice President, One candidate for One post of Secretary and Nine (09) candidates for Eleven posts of EC members. No nomination was received for One post of Treasurer. The scrutiny of Nomination Forms was held on 27.06.2026. All nominations were found valid. The date of withdrawal was on 30.06.2026. No candidate withdrew his candidature. A final list of contesting candidates was displayed on the Notice Board of the undersigned, office of the Society, Website of Society www.mva.org.in and on WhatsApp Group of Society "Met Veterans Association on 01.07.2026.

After completing all the procedural formalities as per the Notification dated 08.06.2026 the General Body Meeting was held on 11.07.2026 at 11.00 A.M. The quorum of the meeting was not completed up to 11.30 A.M., so the meeting was adjourned for fifteen minutes i.e. from 11.30 A.M. to 11.45 A.M. Adjourned meeting restarted at 11.45 A.M. Since number of nominations received were either Equal to or Less than the vacancies available for each Post, for which the election were to be held, hence there was no polling. Therefore, the undersigned announced the result of the following candidates, who were declared ELECTED UNOPPOSED to the Executive Committee of aforesaid Association for the posts noted against each:
